In Bulgaria there are agencies dedicated to public procurement, SOEs and trade and investment and special laws on which they operate.

The Public Procurement Agency supports the Public Procurement Portal (PPP) which is a centralized information system providing access to information about all aspects of public procurement, structured in separate thematic areas and oriented towards the specific interest of the main groups of users. The information is updated on a daily basis. The PPP is public and freely accessible. Both Bulgarian and English versions of the Portal are supported.

The Public Enterprises and Control Agency (PECA) is an administration of the Council of Ministers on budget support.

The Public Enterprises and Control Agency has the functions of a unit that carries out the coordination of the state policy with regard to public enterprises, monitors and reports to the Council of Ministers on its implementation.

The Agency for Public Enterprises and Control organises and carries out the privatisation process in the cases provided for in the Law on Privatisation and Post-Privatisation Control (LPPPC), and carries out post-privatisation control under privatisation contracts concluded by authorised state bodies.

PECA carries out independent external control under the Law on Concessions on certain concession contracts, and performs extraordinary inspections of certain concession contracts, upon assignment by the Coordination Council on Concessions.

Bulgarian small and medium enterprises promotion agency (BSMEPA)

BSMEPA is an institution responsible for conducting and implementing the government's policy in the field of promoting exports as a key factor for economic growth. In this regard, the emphasis is on the implementation of integrated measures to support values, increase investments in export-oriented activities and improve the external financial position of the country.

The main goals and priorities are supporting small and medium-sized businesses in Bulgaria. The aim is to increase the competitiveness of small businesses by supporting start-up and viable small and medium-sized enterprises in their efforts to be innovative, ecological and export-oriented, creating favorable conditions for their development by improving their access to financing.
